FOOD SHELF: THE COVID-19 PANDEMIC CONTINUED TO IMPACT FOOD PROGRAMS AND REQUIRED CONTINUED ADAPTATIONS IN OUR APPROACH. WE MOVED FROM ONLY CURBSIDE DISTRIBUTION AND DELIVERIES TO FULL, IN-PERSON SHOPPING IN JULY 2021. OPTIONS REMAINED IN PLACE FOR THE CURBSIDE PICK-UP AND HOME DELIVERY. OFF-SITE COLLABORATION CONTINUED, SPECIFICALLY AT CIMARRON, A NEARBY COMMUNITY. WE COMMITTED TO SUPPORTING TWICE-MONTHLY FOOD DISTRIBUTIONS IN THIS LAKE ELMO NEIGHBORHOOD. OVERALL FOOD PROGRAM NUMBERS REFLECT AN INCREASE OF 7% IN THE NUMBER OF INDIVIDUALS SERVED YET A 6% DECREASE IN THE NUMBER OF HOUSEHOLDS SERVED. THIS INDICATES LARGER SIZED FAMILIES UTILIZING OUR PROGRAMS. WE HAD A TOTAL OF 17,620 VISITS (DUPLICATED COUNT, INDICATING LEVEL OF USE), AN INCREASE OF 6% OVER THE PRIOR YEAR.
