VALLEY OUTREACH HIGHLIGHTS

Homelessness Prevention Efforts. In early October, we began working with a new county grant program to prevent homelessness. We are off to a good start and the need is great. Within nine business days, we had 42 referrals from partner agencies. This work is not new to us, but the rigor involved, the volume of calls, and the high stakes of the need require us to work in a new way. The homelessness prevention grant is funding the program for two years. It's work we hope to continue to fund going forward.

Growing the Team. We are hiring a new case manager and intake program assistant to support the work of homelessness prevention and the greater numbers of people we are serving. Once these individuals start, we'll have a team of 20 full- and part-time staff!

This year, we serve an average of 800 households per week across all our programs—food, clothing, and client support services. DOROTHY CHISLETTMEMORIAL GIFT IN HONOR OF A
HUSBAND, FATHER, AND SON

In the spring of 2018, the Chislett and McRoberts families, and friends, gathered to say farewell to Wayne D. Chislett. Wayne died at age 51, after a long and debilitating illness. Declining health forced him to step back from a lengthy and rewarding career

at 3M, yet never took away his enthusiasm for staying engaged and doing good in his community. From the obituary— "He was an amazing father and husband, an avid woodworker, and car enthusiast. Even in his illness, Wayne was a devoted volunteer at Valley Outreach food shelf..." Wayne volunteered weekly, sometimes more, until he no longer could physically do so. He made a deliberate choice to be present for families in need despite his own timeline becoming shorter. Wayne's volunteerism created multiple, positive ripples that extended far beyond him. His calm, efficient and friendly dynamic was a joy to be around, and staff and fellow volunteers valued the time spent alongside him.

Five years later, Chantelle McRoberts, his widow, and his daughter, Dorothy Chislett, committed to a \$100,000 gift to the Vibrant Future Fund. They wanted to honor the man who was a selfless volunteer and wanted to recognize that we all have gifts to share—time, money, intention, and generosity. This long-term commitment designates Valley Outreach as the beneficiary of an IRA, one of many means of giving available to donors. Chantelle said, "I told his family about it today and they are thrilled about the donation and the fact he will be recognized. Not bad for a military kid from very modest means..."

Valley Outreach is also thrilled—and incredibly grateful—to be selected as one of the ways Wayne is remembered. We know he would be pleased with the generosity of his family.
